# Summary Annual Report for ABC-NABET Retirement Trust Plan

This is a Summary of the Annual Report for the ABC-NABET Retirement Trust Plan, EIN 14-1284013, for January 1, 2002 to December 31, 2002. The Annual Report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA) and/or Section 6039(D) of the Internal Revenue Code

#### **Basic Financial Statement**

Benefits under the Plan are provided by Trust Funds. Plan expenses were \$25,616,800. These expenses included \$2,944,500 in administrative expenses and \$22,672,300 in benefits paid to Participants and Beneficiaries, and a net depreciation of assets in the amount of \$58,330,500. A total of 3,136 persons were Participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan was \$473,120,900 as of December 31, 2002, compared to \$537,637,400 as of January 1, 2002. During the Plan Year, the Plan experienced a decrease of its net assets of \$64,516,500. This decrease included an unrealized appreciation or depreciation of the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

The Plan had total income of \$19,430,800 including Employer contributions of \$3,336,700, Employee contributions of \$291,300 and earnings from investments of \$15,802,800.
